

June 10, 2023 Belmont Stakes Showdown Contest
OFFICIAL RULES
NO PURCHASE NECESSARY TO ENTER OR WIN

THE CONTEST: The Showdown is a mythical handicapping contest (the “Contest”) taking place on June 10, 2023, at Belmont Park (the “Contest Day”). Please submit any questions regarding the Contest, or these Official Rules via email to Showdown@nyrainc.com.

ELIGIBILITY: Open to legal residents of the continental United States, 18 or older. Employees of The New York Racing Association, Inc. (“Sponsor”), NYRABets, LLC (“NYRA Bets”), and their respective parents, subsidiaries, affiliates, advertising agents and promotional partners, and their immediate families (parent, child, spouse or sibling and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, of such individuals are not eligible to enter or win. By participating, contestants agree to be bound by these Official Rules and the decisions of Sponsor, which are binding and final on matters relating to the Contest. The Contest is subject to all applicable federal, state, and local laws and regulations and is void where prohibited or restricted by law.

TO ENTER: Create your Showdown account by visiting NYRA.com/showdown and following the directions to complete and submit the electronic registration form. To enter the Contest, log-in to NYRA.com/showdown using the information provided at time of registration and submit your Contest selections in accordance with these Official Rules. Contestants may register at any time throughout the Contest Day, but may only make selections and receive bank roll on the remaining races yet to be run on the Contest Day, after completing registration. All entries must be received at least **ten (10) minutes prior to the last Contest race** (the “Contest Deadline”) to be eligible. Limit one (1) entry per person. Multiple entries from any person will be void. Entries generated by script, macro or other automated or mechanical means or by any means which subvert the entry process are void. All entries become the property of Sponsor.

TO PLAY: On the Contest Day, the specific contest format (described below) and races included in the Contest will be published on the America’s Day at the Races or Belmont Live broadcast, and/or at NYRA.com/showdown. Contestants who fail to comply with these Official Rules, including the minimum selection requirements set forth below, will be disqualified and ineligible to receive any prizes. To play, a contestant must log-in to NYRA.com/showdown and make his or her selections in accordance with the following contest format. The Contest will be conducted in the following contest format only:

Win Contest. Select **one (1) horse for each race** included in the Contest. By selecting a horse, contestant is placing a mythical \$10.00 bet on the horse selected to Win.

Please refer to NYRA.com/showdown to see which races are included in the Contest. Contestants may place their selections only at the Showdown website (NYRA.com/showdown). No selections will be accepted in person, by phone or via e-mail. Contestants may not make more than one (1) selection in each Contest race. The contestant is solely responsible for ensuring that his or her selection is correct. Selections for each race must be made at least **ten (10) minutes prior to the post time of that respective race** (“Selection Deadline”). After the Selection Deadline has passed for each race, the corresponding selection is final and contestants will not be permitted to make any changes. Sponsor is not responsible for contestants failing to make selections in

accordance with these Official Rules. Contestants may review their selections and standings at the Showdown website.

In the event that a contestant's selection is a late scratch (within 10 minutes to post) or declared a non-starter for pari-mutuel wagering purposes, the contestant will receive the actual betting favorite in that respective race. Contestants that select a horse, which is part of a coupled entry or mutuel field, will only receive credit for the horse that is the best finisher out of the coupled entry. For example, if horse 1 and horse 1A finish first and second, respectively, a contestant will only receive credit for a single "Win" for horse 1.

WINNER SELECTION & NOTIFICATION: Potential winners and the order of finish will be determined by contestants' bankrolls after all Contest races have been deemed official by Sponsor. Sponsor's decision with respect to winners' determination is final and binding. All winners will be unofficial pending the verification of eligibility and confirmation that all wagers were made in accordance with these Official Rules. Potential winners will receive their prize in their NYRA Bets account or be notified by e-mail with instructions on how to claim the prize and must respond to the initial notification within twenty-four (24) hours of that notification. Sponsor will endeavor to reward the potential Contest Prize to winners within seventy-two (72) hours of the conclusion of the Contest. Potential winners may be required to sign and return an Affidavit of Eligibility, Liability/Publicity Release, and W-9 IRS Form within five (5) business days of initial notification to claim prize. If a potential winner does not respond to the initial notification within the time period stated, a prize or prize notification is returned as undelivered, a potential winner is not available to accept prize, cannot be contacted, or fails to sign and return all required documents within the required time period or is not in compliance with these Official Rules, such potential winner may be disqualified and forfeits the prize. In the event that the potential winner is disqualified for any reason, Sponsor may award the prize to an alternate potential winner in accordance with these Official Rules. Only three (3) alternate winners will be selected for any prize; after which, the prize will remain unawarded.

PRIZE POOL & APPROXIMATE RETAIL VALUE ("ARV"): The prize pool is ten million (10,000,000) NYRA Bets points ("Prize Pool") and is divided among the ten highest finishers at the end of the Contest. If NYRA Bets points are not available in the winning contestant's jurisdiction, Sponsor will award a substitute prize of equivalent value at its sole discretion. The Prize Pool will be divided as follows in order of finish based on the contestants' final bank roll:

1 st	\$5,000 (5,000,000 NYRA Bets Points)
2 nd	\$2,500 (2,500,000 NYRA Bets Points)
3 rd	\$1,000 (1,000,000 NYRA Bets Points)
4 th	\$750 (750,000 NYRA Bets Points)
5 th	\$250 (250,000 NYRA Bets Points)
6 th	\$100 (100,000 NYRA Bets Points)
7 th	\$100 (100,000 NYRA Bets Points)

8 th	<i>\$100 (100,000 NYRA Bets Points)</i>
9 th	<i>\$100 (100,000 NYRA Bets Points)</i>
10 th	<i>\$100 (100,000 NYRA Bets Points)</i>

In the event of a tie, the prize money for both (or all) tied positions will be combined and divided equally among the tied contestants. For example, if two (2) customers tied for 4th place, the prize pool for 4th place (\$750) and 5th place (\$250) will be combined and split evenly among the contestants who tied. Failure to comply with the Official Rules will result in forfeiture of the prize. The Prize Pool NYRA Bets points are redeemable, in jurisdictions where available, only for use by NYRA Bets account holders on NYRABets.com, with an ARV of \$10,000.

PUBLICITY GRANT: Each winner, by acceptance of prize, except where legally prohibited, grants permission for Sponsor and its designees to use his/her name, address (city and state), photograph, voice and/or other likeness and prize information, for advertising, trade and promotional purposes, in any manner, in any and all media now known or hereafter discovered, worldwide in perpetuity, without further compensation or notification to, or permission from, winner.

GENERAL CONDITIONS: By participating, each contestant agrees (a) to abide by these Official Rules and decisions of Sponsor and Contest administrators selected by Sponsor, which shall be final and binding in all respects; and (b) that Sponsor, NYRA Bets, and their respective parents, subsidiaries, affiliates, advertising agents and promotional partners, and all of their respective officers, directors, employees, representatives and agents (collectively, "Released Parties") will have no liability whatsoever for, and shall be held harmless by contestants against, any liability, for any injuries, losses or damages of any kind, including death, to persons, or property resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of any prize (including any travel or activity related thereto) or participation in the Contest. Released Parties are not responsible for lost, late, incomplete, inaccurate, stolen, misdirected, undelivered or garbled entries or email; or for lost, interrupted or unavailable network, server, Internet Service Provider (ISP), website, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Contest, including, without limitation, errors or difficulties which may occur in connection with the administration of the Contest, the processing of entries, the announcement of the prizes or in any contest-related materials. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Contest. Released Parties are not responsible for injury or damage to participants' or to any other person's computer related to or resulting from participating in this Contest or downloading materials from or use of the website. Persons who tamper with or abuse any aspect of the Contest or website or who are in violation of these Official Rules or who act in an unsportsmanlike or disruptive manner, as solely determined by Sponsor, will be disqualified and all associated entries will be void. If, for any reason, the Contest is not capable of running as planned for reasons which may include without

limitation, infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes which may corrupt or affect the administration, security, fairness, integrity or proper conduct of this Contest, the Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Contest in whole or in part. In such event, Sponsor reserves the right to award any remaining prizes in a manner deemed by Sponsor, in its sole discretion, to be fair, appropriate, and consistent with these Official Rules and Sponsor, its subsidiaries and affiliates, and their respective employees, officers, directors and agents shall have no further liability to any contestant in connection with the Contest. All rulings, determinations, and judgements by Sponsor are final. In the event of a dispute regarding entries received from multiple users having the same e-mail account, the authorized subscriber of the e-mail account at the time of entry will be deemed to be the contestant and must comply with these Official Rules. An authorized account subscriber is the natural person who is assigned the e-mail address by the Internet Service Provider (ISP), on-line service provider, or other organization responsible for assigning e-mail addresses. DISPUTES: THIS CONTEST IS GOVERNED BY THE LAWS OF THE STATE OF NEW YORK, WITHOUT RESPECT TO CONFLICT OF LAW DOCTRINES. EXCLUSIVE JURISDICTION AND VENUE FOR ALL MATTERS RELATED TO THIS CONTEST SHALL BE IN THE STATE COURTS OF NEW YORK OR THE UNITED STATES DISTRICT COURT FOR THE EASTERN DISTRICT OF NEW YORK, AND SPONSOR AND CONTESTANT HEREBY AGREE AND CONSENT TO SUCH JURISDICTION AND VENUE. As a condition of participating in this Contest, contestant agrees that any and all disputes that cannot be resolved between the parties and causes of action arising out of or connected with this Contest, shall be resolved individually, without resort to any form of class action, exclusively before a court located in New York having jurisdiction. Further, in any such dispute, under no circumstances shall contestant be permitted to obtain awards for, and hereby waives all rights to, punitive, incidental, or consequential damages, including reasonable attorney's fees, other than contestant's actual out-of-pocket expenses in connection with entering this Contest.
